### Terms for Housing

**Please confirm and acknowledge. Felony Friendly Transitional housing is a program not a rental.** You are **NOT** entitled to any tenant rights, laws and protections under Idaho law. You have no protections under Idaho Code, Title 6, Chapter 3. Know your responsibilities as a program participant. Read your program agreement carefully! Please understand we are not required to give you any notice of any kind to vacate the premises. If asked to leave you must leave as directed by staff. Again you have **NO** Landlord Tenant rights as this is **NOT** a rental. By signing with your signature below you agree that you are of sound mind and not acting under duress or undue influence.

1. 5 \_\_\_ **(initial)** Program Fees are based on amenity range. This range is from: \$625 Shared Room, \$675 Single Room. The \$150.00 maintenance fee covers (twin bed, nightstand, dresser, bed linens, pillow, towels, and wash clothes.) You are not entitled to take the bed, nightstand or dresser with you when you move out. If you are unable to pay the \$150.00 maintenance fee, special arrangements can be made if you contact us in writing ahead of time (text or email) .
2. \_\_\_ **(initial)** Program Fees are due and payable monthly, in advance, on the 1<sup>st</sup> day of each month unless you are funded. Monies shall be made payable to: **Felony Friendly 208. If you do not communicate with the FF208 office about program fees, being late, by 8pm on the 1st you will be locked out of the program property and your room until you communicate with us.** If the program fees have not been received by 5:00 P.M. on the 5th day of the month, after an agreed upon extension, the participant will be charged a \$100.00 late fee. The late fee will be part of the agreement made with FF208.
3. \_\_\_ **(initial)** Payment Plans: If you are under a payment plan with FF208 there will be no extensions as a payment plan is already an extension of FF208's original agreement to pay program fees in a timely manner. Payment options are as follows:
  - a) All program fees are due on the 1st with no late penalties if you have prior approval to pay up until the 5th.
  - b) Half program fees due on 1st and the other half on the 15th to include late fees since full payment will not be made until after the 5th.
  - c) Weekly program fee payments of calculated amounts to be paid every 7 days to include late fees since full payment will not be made until after the 5th.
4. \_\_\_ **(initial)** In the event you do not pay your programs fees and you leave your personal property at the program property, with no agreement, we will immediately box up your personal property and put in secure storage for the cost of \$30.00 per day (storage fee). All your opened dry food goods and refrigerator and freezer items will be disposed of or donated. To retrieve your property you will need to pay current for the days your property was at program property along with any days your property was in storage. We will only hold your personal property in storage for 30 days, after that we will dispose or donate it.

5. \_\_\_\_ **(initial)** Termination from program: Any FF208 Reentry Coordinator can terminate you from the program with just cause. All terminations must have final approval from Katie Boyer or Dennis Richardson. Termination from the program can be anything from a 30 day notice or an immediate eviction at that same moment depending on severity of situation and or negotiated arrangements made by FF208 staff leads (Dennis or Katie).
6. \_\_\_\_ **(initial)** I understand I will not borrow and loan any money to any current participant for any reason. FF208 will not be liable for any losses taken from not following this provision. If mediate is required to settle a dispute, all participants must be present and agree to a mediate session at the FF208 office.
7. \_\_\_\_ **(initial)** I understand I will only be allowed to park one running vehicle at the residence. I understand that I am never to park or store a motorhome, camper, trailer, boat or any sort of recreational vehicle on the premises and to park only automobiles on the paved areas provided. Junk cars, cars on blocks, non-functional vehicles, or unlicensed automobiles are not permitted on property. I understand that I am responsible for any expenses involved with removal or towing of unauthorized vehicles. I understand if my vehicle leaks any fluid I may not park on any driveway. Any damage I cause to driveways will be my responsibility to pay to have cleaned. I also understand that I am to follow the city ordinance concerning parking. If a vehicle/property is left at the property it will be stored and/or retrieved at your own expense. \$40 a day storage fee, and possible liens can be filed.
8. \_\_\_\_ **(initial)** I understand that I am to follow all conditions set forth by Probation and Parole.
9. \_\_\_\_ **(initial)** I will actively engage in programming set forth by Felony Friendly 208 and/or I.D.O.C./P&P as directed.
10. \_\_\_\_ **(initial)** I understand that I will have full-time employment (30-40) hours per week within thirty (30) days of occupancy. Failure to obtain employment can result in termination from the program. Special arrangements can be considered.
11. \_\_\_\_ **(initial)** No business that potentially violates health and safety codes or requires an occupational license can be conducted on FF208 property grounds. Examples: tattoos or piercings, pest control, cosmetology, cooking, etc.
12. \_\_\_\_ **(initial)** No guests will be allowed in or on the program property, without prior written approval (text or email). If you need to meet with someone you must do so off the program property. Any violation of the visitor policy could result in visitation restrictions to immediate eviction.
13. \_\_\_\_ **(initial)** All participants must be fully clothed while in any common areas.
14. \_\_\_\_ **(initial)** All participants may not be involved in any sexual activities in the house.
15. \_\_\_\_ **(initial)** No inappropriate wall hangings, examples: nude photos, nude posters, etc.
16. \_\_\_\_ **(initial)** I will encourage recovery, sobriety and life progression at all times in the program.
17. \_\_\_\_ **(initial)** All prescription medications must be placed in a lock box provided by the participant.
18. \_\_\_\_ **(initial)** I understand that all violations will be reported immediately to my probation/parole officer by the house owner/Reentry Coordinator.
19. \_\_\_\_ **(initial)** I will participate and attend all scheduled house meetings, conflict/resolution interventions, and individual meetings as directed by the Reentry Coordinator. Missed meetings will result in an individual meeting with FF208 staff at FF208 central office.
20. \_\_\_\_ **(initial)** I will immediately report to Felony Friendly 208 any problems arising from my current living situation.
21. \_\_\_\_ **(initial)** I will not engage in aggressive or confrontational behavior. Any verbal or physical acts of aggression or intimidation will result in the immediate removal from the program.
22. \_\_\_\_ **(initial)** I understand and agree that any and all program fees paid will be non-refundable regardless of when I enter or leave the program.

23. \_\_\_\_ **(initial)** I understand that in the event of an emergency, I am to proceed to the nearest marked fire exit and exit the premises as instructed immediately. Exits are marked above doors and windows. I further understand that I am not to disable, modify, or in any way tamper with any and all smoke detectors, CO detectors, and fire extinguishers and that doing so can result in immediate termination from the program.
24. \_\_\_\_ **(initial)** I understand and release Felony Friendly 208 Housing, its representatives, and program participants from any liability in the event of injury on the property.
25. \_\_\_\_ **(initial)** I understand that this is an animal free program. I will not feed any stray animals on the property.
26. \_\_\_\_ **(initial)** I understand for correspondence, I must text the above phone number or send an email to the email address if it is in regards to Felony Friendly 208 business to get a response. Action will not be taken if that is not completed.
27. \_\_\_\_ **(initial)** I understand if I notice equipment or furnishings broken, I will communicate that with Felony Friendly 208 within 24 hours. I will not use the equipment or furnishings again until approval from Felony Friendly 208.
28. \_\_\_\_ **(initial)** I understand Reentry Coordinators will do random house checks anytime of the day or night. We will knock on your bedroom door and if no response will enter. FF208 will enter every room multiple times a week and conduct searches if necessary. Definition of Reentry Coordinator: Anyone working/volunteering for FF208. Reentry programs are designed to assist incarcerated individuals with a successful transition to their community after they are released. Improving reentry is a critical component to reduce drug use and its consequences. This includes administering needs assessments, reviewing reentry and personal action plans, employment and housing search assistance, accessing wrap-around services in communities, conducting wellness check-ins, facilitating classes, employment verifications and other case management needs.
29. \_\_\_\_ **(initial)** I understand I will not remove or exchange any furniture or household items that are provided by Felony Friendly 208. If items are removed or exchanged you will be charged the cost of the items.
30. \_\_\_\_ **(initial)** I understand I will use the correct cleaning supplies in the designated appliances. If damage is caused by myself I will be responsible for repairing or replacing the appliance.
31. \_\_\_\_ **(initial)** I understand I will not use additional heaters, air condition units, or refrigerators in program participants' sleeping quarters or in common areas unless provided by Felony Friendly 208.
32. \_\_\_\_ **(initial)** I understand I will not burn candles, incense or use wickless candles in my sleeping quarters or in common areas.
33. \_\_\_\_ **(initial)** I understand I will not discriminate of any kind: crime, race, age, disability, sexual orientation, religious or national origin.
34. \_\_\_\_ **(initial)** I understand if I change my contact information (email or phone number) I will provide that information to FF208 within 48 hours.
35. \_\_\_\_ **(initial)** FF208 gives direct notification hereto that FF208 utilizes surveillance devices on the property. However, FF208 does not record anyone without their consent in places where there is an expectation of privacy. That includes places like bathrooms, changing rooms, private bedrooms, etc. ... Idaho recording law stipulates that it is a one-party consent state. In Idaho, it is a criminal offense to use any device to record communications, whether they are wire, oral or electronic, without the consent of at least one person taking part in the communication. This serves as your official one-party consent notice.
36. \_\_\_\_ **(initial)** Photos and Videos: FF208 staff will frequently take photos or videos for evidentiary purposes of rule violations and of law violations. At least one party must give consent before someone can record an in-person conversation in Idaho. Idaho Code Ann. § 18-6702(2)(d). Consent, however, is not required to record an in-person communication spoken by a person who does not have a reasonable expectation of privacy in that communication. While in FF208 housing you have NO expectation of privacy except in the bathroom or bedroom unless FF208 makes proper entrance and announcement. Please review rule #35.

37. \_\_\_\_ **(initial)** Internet usage needs to be individually regulated. Each individual will only be allowed to have no more than 2 devices hooked up to the internet at a time. More than 2 devices hooked to the internet by a single individual will not be allowed. Wifi booster devices will not be allowed. Anyone caught touching FF208 equipment of any kind will be removed from the program.
38. \_\_\_\_ **(initial)** No participants are allowed to sleep in the common rooms. All personal items must be kept in your assigned room. Do not leave any personal belongings in the common rooms.
39. \_\_\_\_ **(initial)** Seniority moving from shared to single rooms. You must meet these criterias:
  - a. Clean living space at all times
  - b. No Failed U/A
  - c. No Arrests or Sanctions within Drug Court
  - d. Must stay at the residence more than 15 days out of the month
  - e. Must pay program fees on time

**\*\*All personal belongings are not covered by insurance, Felony Friendly 208 is not responsible for missing or stolen property. We will do an investigation to try to recover your property. You are responsible to lock up your valuable belongings at your own expense.**

### Accountability

- 1) \_\_\_\_ (initial) Cleanliness
  - a) No dirty dishes in sink
  - b) Must clean up kitchen/cookware after every time you cook a meal
  - c) Must not leave laundry in washer or dryer after cycle is complete
  - d) Must provide a laundry hamper to use for dirty laundry at own expense
  - e) Be considerate of other house members during the night while in common areas
  - f) All program participants are required to do some type of outside work, for example: mow lawns, rack leaves, snow shovel the driveway/sidewalks.
  - g) FF208 will be conducting daily walkthroughs of the program property to make sure the program property is clean and functioning. If there are any problems with the daily walk through you will have 1 day to get the issues resolved.
  - h) I am responsible for the cleanliness of my living quarters daily. There will be NO smoking inside of the residence which also includes vaping.
  - i) Basic cleaning supplies will be provided and if the residence runs out you will notify Felony Friendly 208 by email.
- 2) \_\_\_\_ (initial) Dirty UA or Admittance I will not consume or possess alcohol or controlled substances at any time for any reason. I further understand and agree that violation of this rule could lead to the sanctions below. Depending on severity please understand we can accelerate the consequence to immediate eviction. I agree to submit to random blood alcohol content testing (BAC) and/or urine analysis and understand that refusal to provide a breath/urine sample at the time of request could result in immediate removal from Felony Friendly 208 Housing.
- 3) \_\_\_\_ (initial) Narcan Kits installed at each location. Instructions are posted on corkboard. If the Narcan is used, you must notify Felony Friendly 208 immediately.

**In signature, I acknowledge and accept these terms and understand that I am excluded from the due process afforded by local landlord-tenant laws in that: If I violate any rules I agree to voluntarily vacate the premises within twenty-four hours of receiving verbal or written notice from Felony Friendly 208 Housing. I agree to follow all directives mandated by the House Manager and/or Reentry Coordinator of Felony Friendly 208 Housing. Rules can change and or be updated at any time. This serves as verification that I have thoroughly read, or have read to me, the above contract/terms and understand all terms outlined herein and have received a signed copy of this contract. As well your signature represents your Release of Information between FF208 and Probation and Parole.**
